Chairman Kevin Riley called the meeting to order at 6:02 p.m.

A motion was made by Julian Hutchinson and seconded by Sandie Perry to approve the minutes of September 16, 2015. Motion carried 6-0.

A request was presented for approval from Janet Horstman to paint around windows of building at 120 S. Water Street. The members were not clear of exactly what colors and plans were for this building. **A motion was made by Sandie Perry and seconded by Julian Hutchinson to deny the request as presented as they would like to see the plans of what they would like the front of the building to look like. Motion carried 6-0.**

A motion was made by Deb Moore and seconded by Pat Eggers to approve the paint colors of mountain slate blue and cream for the wood portion of the building for Mark Lakowske at Healing Artistry Therapies at 111 W. Oak Street. Motion carried 6-0.

A motion was made by Sandie Perry and seconded by Deb Moore to approve the paint colors of blue with cream for Second Season owned by Phyllis Frisk at 128 N. Water Street. Motion carried 6-0. Phyllis is to check with Todd Fahning on the awning regulations and then bring to Historic Preservation for approval along with her sign design to be approved.

A motion was made by Pat Eggers and seconded by Julian Hutchinson to approve the installation of 14 windows for Mark Meyers for his building at 117 E. Oak Street as the picture he provided shows. Motion carried 6-0.

A motion was made by Paul Kuester and seconded by Julian Hutchinson to approve the paint colors of red with cream trim same as the Arndt, Buswell, & Thorn building for Roger Oswald at 107 W. Oak Street. Motion carried 6-0.


