### RESOLUTION ADOPTING BUDGET FOR THE YEAR 2023

WHEREAS, the Finance Committee has submitted and filed its proposed budget for the City of Sparta for the ensuing calendar year, and

WHEREAS, a summary of such budget and notice of time and place of public hearing thereon has been published as provided by law, and such public hearing has been held on the 7th day of December, 2022, and it has been determined after such hearing that such budget be adopted after making alterations thereof as heretofore determined by the Common Council.

NOW THEREFORE, BE IT RESOLVED, BY THE COMMON COUNCIL OF THE CITY OF SPARTA, MONROE COUNTY, WISCONSIN, that the budget for the year 2023 for said City of Sparta, setting forth anticipated receipts in the sum of \$15,586,923.81, be and the same is hereby adopted, and anticipated total expenditures in the total sum of \$15,847,103.16, be and the same is hereby adopted.

BE IT FURTHER RESOLVED that there be appropriated out of the receipts of the City of Sparta for the year 2023, including monies received by the general property tax levy to the various funds and purposes set up in the said budget for the purposes therein stated and in the respective amounts therein stated.
