## CITY OF SPARTA PUBLIC WORKS MINUTES March 5, 2024

Kevin Brueggeman called the meeting to order at 6:00 p.m.

A motion was made by Bryan Jandt and seconded by Paul Geier to approve the consent agenda consisting of the minutes of the February 6, 2024 meeting; Director of Public Works Report for March; Water Utility Operation and Waste Water Treatment Plant Reports for February; Waste Water Treatment Plan Annual Report; and monthly bills for February. Motion carried 5-0.

Todd Fahning presented the preliminary plat review for Todd Page. He stated they intend to construct 38 lots for condominium units and possibly some single-family homes. The preliminary plan shows the general layout. The proposed sidewalk will be part of the final plat review. Todd stated the City is working with MSA and Todd Page's engineer on the water looping portion of the project as a cost share for both parties. The water looping for the City's portion is a TID 10 expenditure. They will also be donating approximately 20 acres for park space.

A motion was made by Bryan Jandt and seconded by Kevin Brueggeman to approve the preliminary plat review for Todd Page. Motion carried 5-0.

Mark Van Wormer presented the proposed Urban Area Boundary Map from the Department of Transportation. He stated the DOT generates these maps after every census. Mark and Todd discussed the proposed map with a representative from the DOT and stated the mapping areas affect grant funding. If Public Works approves the proposed map changes, it will be presented as a resolution to the City Council.

A motion was made by Troy Harris and seconded by Paul Geier to approve the Urban Area Boundary Map. Motion carried 5-0.

Mark stated US Cellular currently leases water tower space since 2006. The lease was amended in 2017 after MSA reviewed it and adjusted per the rest of the state. US Cellular wants an updated lease as they are changing equipment. There will not be an increase; however they will pay for the inspection per our request.

A motion was made by Paul Geier and seconded by Kevin Brueggeman to approve the US Cellular lease of the water tower space. Motion carried 5-0.

A resident who lives on the corner of Chester Street and Pine Street is requesting a handicap sign be installed near the side entrance to their home. They do have a garage with a very short

driveway, but it is a distance from the entrance to the home. Adding the signage would not make them exempt from alternate side parking in the winter months.

Troy Harris made a motion to deny the handicap sign located at 400 Pine Street. There was no second.

A motion was made by Kevin Brueggeman and seconded by John Gessner to approve by roll call vote the handicap parking space located at 400 Pine Street. Motion carried 4-1, with Troy Harris voting no.

Kevin Brueggeman discussed the brush dump disposal area. He discussed possibly installing a sign stating \$100 per month fee for companies to dispose of brush and stumps. He questioned how much the City pays for grinding the stumps that are dumped at the site. Dennis Johnson stated in 2023 it was just below \$6,000 for them to bring in the chipper and haul away. Monroe County used some as road base, as well as Gerke Excavating. He stated its not usually a problem getting rid of it. Mayor Riley commented that some do take advantage of the dump site, but alleviating it would probably not happen. He believes we would be creating more work and problems by implementing a policy.

Troy Harris stated he received calls questioning where residents can bring their used cooking oil. Todd Fahning stated that local restaurants will take the used oil. Troy asked if a barrel could be placed at the street shop for the purpose of resident dumping of used cooking oil.

There were no items for future consideration.

A motion was made by Troy Harris and seconded by Kevin Brueggeman to adjourn at 6:30 p.m. Motion carried 5-0.

#### **Airport**

#### **Project Updates**

#### John St. Reconstruction

Restoration and seeding will proceed in the spring due to the weather conditions.

#### **South Pointe Phase 3**

A preliminary design meeting for expanding the South Pointe Business Park was held with MSA to discuss future road and utility construction. Bid plans are on Quest and bids will be reviewed at the April Public Works Meeting. The plan is to excavate the eastern side of the park this spring to create a large parcel for potential development.

#### Sand Creek Landfill

The WI DNR is investigating the Sand Creek Landfill and is going to be requiring the City and County to add additional monitoring at the site to determine if action at the landfill is required to contain potential contamination. An engineering firm has been selected and Culligan has installed filters designed for the contaminants detected. The landfill area was both County and City so coordinated investigation will be required. We are working with MSA to design a municipal water line to the area to supply water.

#### **Miscellaneous**

The Street Department is working on tree removal/trimming and snow operations. Boulevard trees have been ordered and will be planted when available.

#### City of Sparta Water Utility

#### **Operation and Maintenance Report**

#### March, 2024

In March we pumped 38,910,000 gallons of water compared to 37,640,000 gallons for the same period last year.

The following is a list of what the Water Utility has been working on during the month of March:

- Completed the monthly bacti samples.
- Completed monthly fluoride sample.
- Ran generators for the monthly tests.
- I have completed the Annual Drinking Water Quality Report. Our drinking water continues to meet federal and state requirements. A notice will be placed in with the water bills to customers with a URL link to access the report. It is also available to our customers at City Hall, upon request, and is on the City of Sparta website.
- Our accountant, billing clerk and myself worked with the auditors to complete the yearly audit. Our unaccounted water for 2023 was 2.4%, which is excellent. Our 10-year average is 4.6%. The PSC limit is 15%.
- We received a supply of chemicals for the wells from Hawkins Inc.
- We replaced a chemical transfer pump for the fluoride at well 7.
- Midwest Testing completed testing of our large meters and commercial & industrial cross connection inspections that were due in 2024.
- Water Utility staff attended a Western Wisconsin Water Professionals seminar in Tomah and the WRWA conference in La Crosse this month. There were several water related topics discussed and credits were issued for our licenses.
- Employee Brian Betts has decided to transfer to the Park Dept. and fill the opening they have. We have since hired his replacement, Brent Harris, will start with the Utility the first part of April.
- We will be conducting our spring city wide hydrant flush the week of April 15th. A notice to customers will be in the paper and on the City website.
- We are doing some interior painting at some of our facilities, as time allows.
- We continue to work on customer material inventory surveys and residential cross connection inspections throughout the system.
- We are repairing and lowering curb boxes and valve boxes that were hit during snow plowing or heaved by the frost as needed.
- We completed monthly meter reading route for our large customers.

- Continue to do routine jetting when weather permits.
- Continue to work on plant work orders.
- Skylar Holzhausen is our new hire and started on March 4; he was previously an operator at the Rockland plant.
- Skylar, Casie and I attended WRWA Annual Conference in LaCrosse.
- Sable Mechanical has completed repairs on the North Final Clarifier.
- On March 1<sup>st</sup> we switched our chemical that we use to treat phosphorus. So far,
  the results are excellent. The cost of new chemical is quite a bit more, but results
  are significant. We are also using less than half of what we were using. We have
  also eliminated feeding polymer that we were also using. Overall, we should see
  a cost savings by using new chemical.
- Casie Manke passed his Solids Separation Exam.
- On March 21<sup>st</sup> we had a power issue at plant. Main breaker for entire plant tripped out. Back p generator did run. Two VFDs for RAS pumps shorted out along with two in line surge protectors. We have gotten replacement VFDs installed, and RAS pumps are operational again. Surge protectors are on order.
- Replaced mixer number 2 in GBT wet well.
- We have completed sludge analysis and are getting ready for sludge hauling first part of April.

#### LEACHATE ACCEPTANCE AGREEMENT

WHEREAS, the Vernon County Landfill generates leachate as part of its active landfill operations; and,

WHEREAS, the Vernon County Landfill generates an average of 2.5 million gallons of leachate per year; and,

WHEREAS, the Vernon County Landfill pursuant to NR 506.13 Wis. Admin. Code is required to remove all leachate from the leachate collection system and dispose of it at a wastewater treatment facility; and,

WHEREAS, the City of Sparta operates a waste water treatment facility at 805 Richgruber Road, Sparta, WI 54656; and,

WHEREAS, the Vernon County Landfill currently delivers leachate to the Sparta Waste Water Treatment Facility for treatment and disposal; and,

WHEREAS, the City of Sparta reserves the right to terminate this Agreement without prior notice if leachate is found to be toxic or incompatible with the City if Sparta Treatment Plant, or causes the treatment plant to exceed the limits set by the WPDES Permit:

NOW THEREFORE, in consideration of the foregoing premises and the mutual covenants and agreements contained herein, the parties do agree to the following:

- 1. This agreement is entered into between Vernon County Landfill and the City of Sparta.
- 2. The City of Sparta will continue to receive Leachate from the Vernon County Landfill.
- 3. The City of Sparta currently charges \$24.67 per 1000 gallons of leachate, and may increase that amount as costs warrant. The City of Sparta shall give Vernon County Landfill 30 days-notice of any increase in the fee charged for accepting the leachate.
- 4. This agreement may be terminated by either party at any time.
- 5. This agreement shall be governed by the laws of the State of Wisconsin and any lawsuits arising from this agreement shall be resolved in Monroe County Circuit Court, Monroe County, Wisconsin.
