Kevin Riley called the meeting to order at 6:00 p.m.

**A motion was made by Deb Moore and seconded by Cindy Arenz to approve the consent agenda consisting of the minutes from the August 21, 2019 meeting. Motion carried 5-0.**

Chris Moretti, dba Decals with Distinction located at 219 S. Water Street is requesting sign approval. He would like to put up a 4 X 8 aluminum sign on the front of the building with his logo. **A motion was made by Sandie Perry and seconded by Kevin Riley to approve the sign request for Chris Moretti, dba Decals with Distinction, located at 219 S. Water St. as presented. Motion carried 5-0.**

Linzi Rebik, dba Nature's Touch Massage located at 122 S. Water Street is requesting window signage/decal approval. **A motion was made by Deb Moore and seconded by Sandie Perry to approve the window signage request for Linzi Rebik, dba Nature's Touch Massage, located at 122 S. Water Street as presented. Motion carried 5-0.**

Kristine Silvernail, dba Sparta Dance Academy located at 103 W. Oak Street is request window signage/decal approval. She has already put up mesh window coverings over the door and the windows. She stated she was not aware of the rulings for window coverings nor about being in a Historic District. Since there are a lot of bars in the area and she has young students, she is concerned about their safety. She has also installed curtains behind the mesh that would cover the lower half of the windows. Our ordinance states that no more than 25% of the glass area can be covered up, especially in the Historic District. The Commission members gave her an idea of cutting around the dancers so more of the window would show. **A motion was made by Cindy Arenz and seconded by Pat Eggers to approve the changes as discussed for the Sparta Dance Academy located at 103 W. Oak Street. Motion carried 5-0.**




