**ORDINANCE NO. \_\_\_\_\_**  
**ORDINANCE PERTAINING TO TRUANCY IN VIRTUAL LEARNING**

THE COMMON COUNCIL OF THE CITY OF SPARTA, MONROE COUNTY, WISCONSIN, DO ORDAIN AS FOLLOWS:

Section 1. Sec. 9-205 of the Code of City Ordinances is hereby amended to read as follows:

A person under 18 years of age is prohibited from being a truant as defined in Wis. Stats. § 118.163(1)(d). Penalties available to the court for violation of this division are as provided in Wis. Stats. § 118.163(1m).

(a) For purposes of this ordinance, the term “absent from school” in Wis Stat 118.163(d) is defined as follows:

a. For in-person schooling, a student not in attendance in the classroom when school is in session and students are required to be physically present,

b. For virtual schooling requiring attendance in an online classroom, a student not in attendance of an online classroom when the online classroom is in session, or

c. For virtual schooling not requiring attendance in an online classroom, students shall follow the attendance policy and expectations set forth by the school district.

(b) Any student who is absent from school as defined in this ordinance without an acceptable excuse under Wis Stats. 118.15 and 116.16 (4) for part or all of any day on which school is being held during a school semester shall be deemed truant.

Section 2. This ordinance amendment shall be in full force and effect following its passage and publication as provided by law.

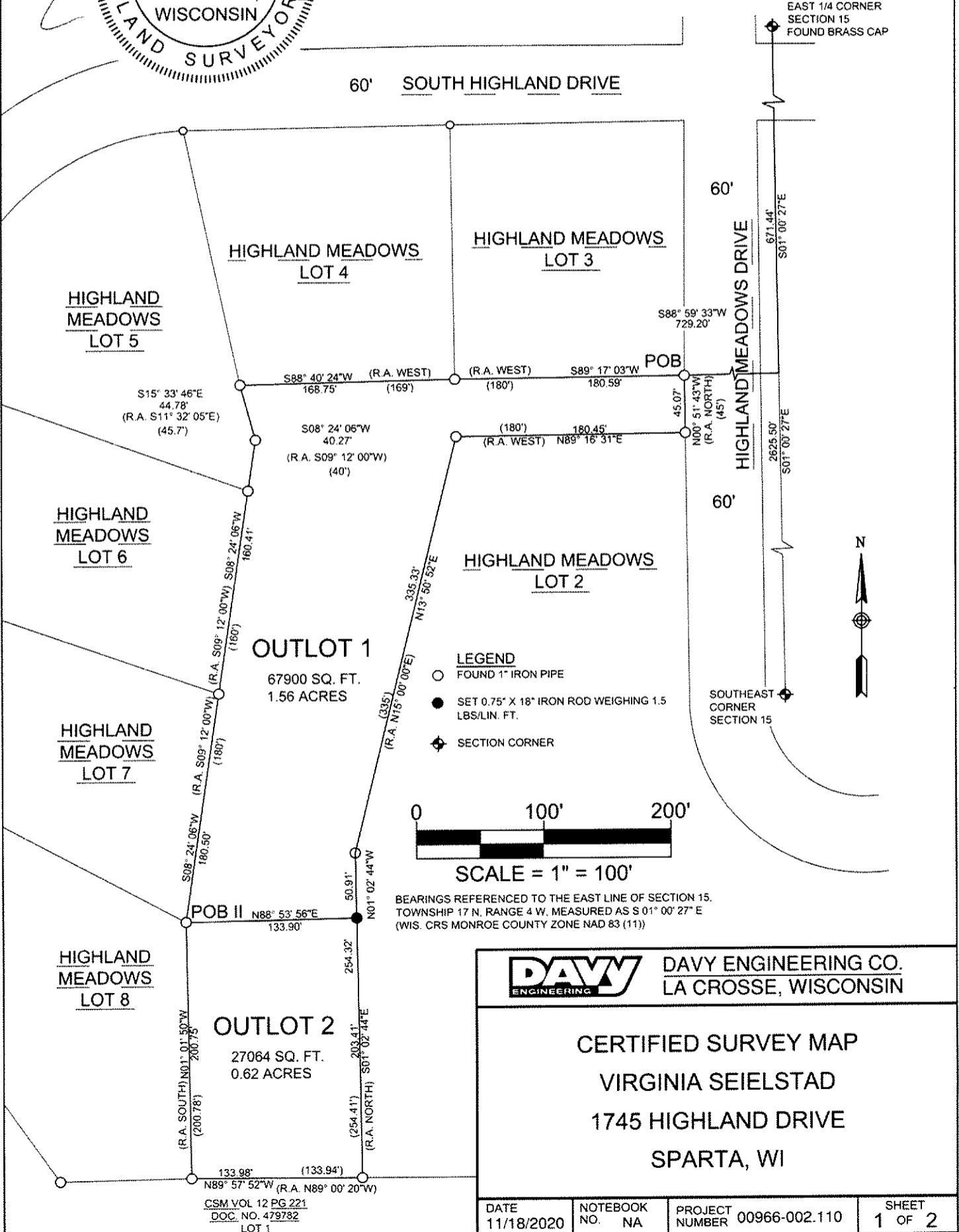
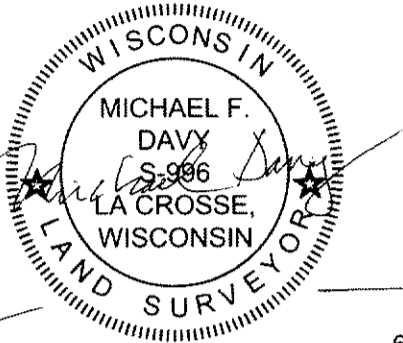

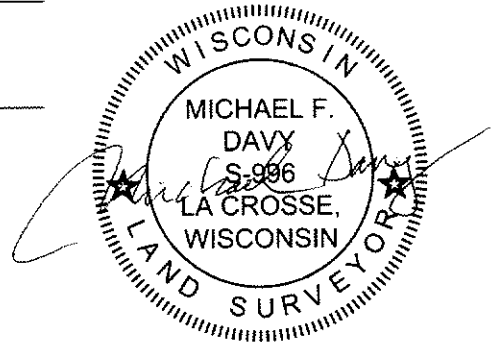
