The meeting was called to order by the City Clerk at 5:30 p.m.

The first order of business was to nominate a Chairman. Mike Jamesson nominated Ed Lukasek, seconded by Jennifer Wangen. Nominations were closed and Ed Lukasek named Chairman of this Commission.

A motion was made by Deb Moore and seconded by Jennifer Wangen to approve the consent agenda consisting of the minutes from the March 15, 2022 meeting. Motion carried 4-0.

Tucker and Michelle Bills have purchased the building located at 106 N. Water Street and have presented an application with a list of improvements they would like to do. The name of their business will be Matsumoto Ramen House, the sign will be made of aluminum and will be 10' wide X 7' high and may be white or a cream color. The awning will be replaced with a new black awning, the wood on the top of the building will be removed and the brick underneath will be repaired. The area under the windows and between the door and one window will either painted, stained or if there is brick underneath, it will be repaired. They aren't sure what they will find underneath. **A motion was made by Mike Jamesson and seconded by Deb Moore to approve their plan for improvements unless they come across any structural damage. Motion carried 4-0.**

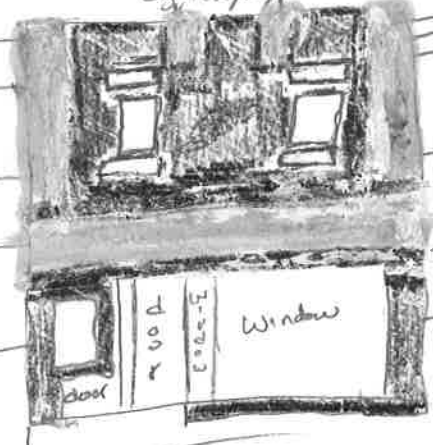

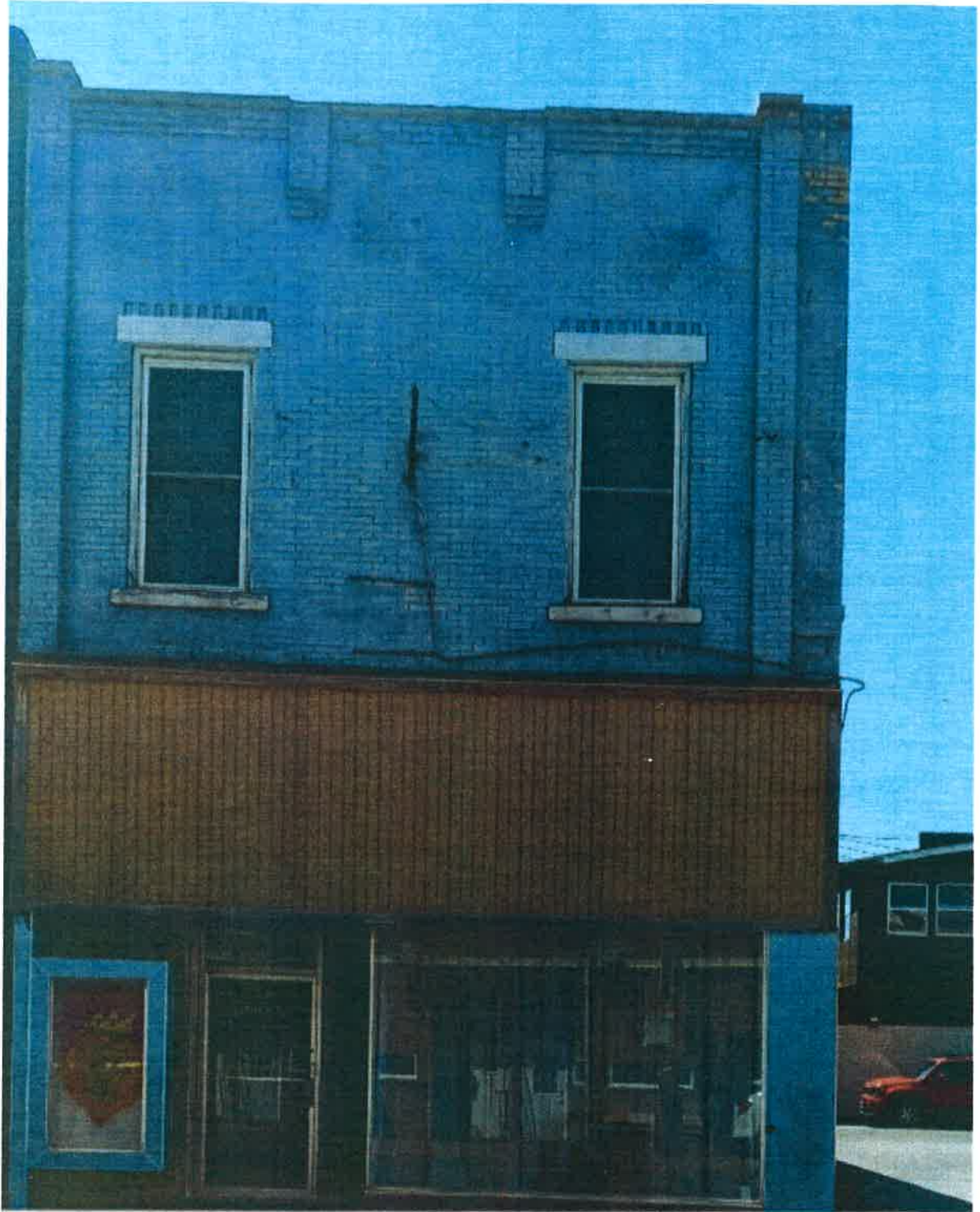
