Ed Lukasek called the meeting to order at 5:30 p.m.

A motion was made by Sandie Perry and seconded by Jennifer Wangen to approve the consent agenda consisting of the minutes from the May 3, 2022 meeting. Motion carried 5-0.

Frank and Bethany Schanenberger were not present at the time of the discussion. Ed Lukasek explained the color choices they are wanting to paint on the exterior of the building. The windows and the doors will remain the same for now. The committee agreed the painting would be a significant improvement.

A motion was made by Jennifer Wangen and seconded by Mike Jamesson to approve the color options for painting the exterior of the building. Motion carried 5-0.

Beau and Jeanette Burlingame of Sparta Bottling Co. presented exterior plans designed by HSR Associates. They are remodeling the old Sparta Police Department located at 121 E Oak Street. Their plan is to retain the stonework as is and add stonework where needed to match the existing. They will install a new front door, new concrete patio with new fencing, and a shrub hedge at the sidewalk.

A motion was made by Mike Jamesson and seconded by Deb Moore to approve the outside improvements to include the storefront windows and doors, new front door, stonework, lighting, and fencing for Sparta Bottling Co. located at 121 E Oak Street. Motion carried 5-0.

Items for future consideration were:

Mike Kidd of Prestige Furniture has purchased the Mike's TV and Appliance building at 119 S Water Street. He will have an application to present at the next Historic Preservation meeting.
